DECISION OF THE BOARD:

1. This is an application for accreditation in which the applicant seeks to be accredited as the bargaining agent for certain employers who have a bargaining relationship with the respondent. The respondent is party to a collective agreement with The Boilermaker Contractors' Association dated July 1, 1971 the term of which runs from July 1, 1971 to June 30, 1973. No question arises that more than one employer affected by this application is bound by that agreement and the Board therefore finds that it has jurisdiction under section 113 of the Act to entertain this application.

2. The applicant in the present case is a Corporation. In support of its application the applicant filed a copy of Letters Patent dated September 1, 1972, given by the Minister of Consumer and Commercial Relations for the Province of Ontario. These Letters Patent create The Boilermaker Contractors' Association of Ontario a Corporation without share capital. The applicant also filed a copy of By-Law No. 1 of the applicant association dated January 19, 1973. On the basis of the materials filed with the Board we are satisfied that the applicant employers' organization is an employers' organization within the meaning of section 106(d) of The Labour Relations Act and that it is a properly constituted organization for the purposes of section 115(3) of the Act.

3. The applicant also filed in support of its application 56 documents entitled Power of Attorney. These documents appoint the applicant as agent and representative for collective bargaining with the respondent and they further appoint the applicant as agent and representative to make an application for accreditation under The Labour Relations Act. The applicant also filed in support of these documents a duly completed Form 62, Declaration Concerning Representation Documents. The Board is satisfied that the evidence of representation meets the requirements set out in section 96 of the Board's Rules of Procedure and the Board is further satisfied that the individual employers on whose behalf the applicant has submitted evidence of representation have vested appropriate authority in the applicant to enable it to discharge the responsibilities of an accredited bargaining agent.

4. The collective agreement referred to in paragraph 1 affects a geographic area involving 8 Provinces, one of which is the Province of Ontario. The applicant and the respondent agreed that the appropriate geographic area for accreditation in the present application is the whole of the Province of Ontario. The applicant and the respondent further agreed that pursuant to the collective agreement referred to employees have been employed in the following sectors of the construction industry:

Industrial, Commercial and Institutional;  
Residential;  
Sewers, Tunnels and Watermains;  
Heavy Engineering.

Although an intervention was filed by the Electrical Power Systems Construction Association, since the present application does not affect the Electrical Power Systems sector of the construction industry they have withdrawn from the application. In view of the above the Board further finds that all employers of employees for whom the respondent has bargaining rights in the Province of Ontario in the industrial, commercial and institutional, residential, sewers, tunnels and watermains and heavy engineering sectors of the construction industry, constitute a unit of employers appropriate for collective bargaining.

5. Notice of this application was given to 117 employers in accordance with the Board's Rules of Procedure. At the hearing in this matter the applicant and the respondent agreed that the following employers should be removed from the list of employers in the unit of employers because the respondent was not entitled to bargain on behalf of their employees in the geographic area and sector in a unit of employers:

The Board finds that the fifty-two (52) employers on Final Schedule "E" were those employers who had employees in the year immediately preceding the making of the application, and the number fifty-two (52) is the number of employers to be ascertained by the Board under section 115(1)(a) of the Act.

9. On the basis of all the evidence before us the Board finds that on the date of the making of the application the applicant represented thirty-six (36) of the fifty-two (52) employers on Final Schedule "E". The thirty-six (36) employers is the number of employers to be ascertained by the Board under section 115(1)(b) of the Act. Accordingly, the Board is satisfied that a majority of the employers in the unit of employers are represented by the applicant.

10. The Schedule "H" which accompanied the Form 68, Employer Filing, filed by the individual employers sets out the number of employees that the employer has at each job site with details of the location and the type of construction involved. By section 115(1)(c) of the Act, the payroll period immediately preceding the making of the application is the relevant weekly payroll period for determining the number of employees affected by the application.

11. The Employer Filing further provides that an employer can claim that this payroll period is not the relevant payroll period for the purposes of this application. A number of employers in the present case made such a representation to the Board in their filing. These employers were further contacted by a Board examiner and asked to supply three representative payroll periods. A number of employers so contacted did not make any further filing. Accordingly, for the following employers the Board

proposes to use the payroll period immediately preceding the making of this application:

For the remaining employers the Board is satisfied that the weekly payroll period immediately preceding January 31, 1973, is a satisfactory payroll period for the determination in section 115(1)(c) of the Act. On the basis of all the evidence before us and in accordance



with the foregoing considerations the Board finds that there were six hundred and sixty-six (666) employees affected by the application during the payroll period immediately preceding January 31, 1973. The six hundred and sixty-six (666) employees is the number of employees to be ascertained by the Board under section 115(1)(c) of the Act.

12. The Board further finds that the thirty-six (36) employers represented by the applicant employed four hundred and eighty-five (485) of these six hundred and sixty-six (666) employees. The Board is therefore satisfied that the majority of the employers represented by the applicant employed a majority of the employees affected by the application as ascertained in accordance with the provisions of section 115(1)(c) of the Act.

13. Having regard to all of the above findings a Certificate of Accreditation will issue to the applicant for the unit of employers found to be an appropriate unit of employers in paragraph 4, and in accordance with the provisions of section 115(2) of the Act for such other employers for whose employees the respondent may after January 31, 1973, obtain bargaining rights through certification or voluntary recognition in the geographic area and sectors set out in the unit of employers.
