

EMPLOYEE BARGAINING AGENCY DESIGNATION

Pursuant to subsection 5 of section 153 of the *Labour Relations Act, 1995*, the designation of the United Brotherhood of Carpenters and Joiners of America and the Ontario Provincial Council of the United Brotherhood of Carpenters and Joiners of America dated March 3, 1978 and amended April 10, 1980, is further amended by the substitution in paragraph one of the "Ontario Provincial Council" with the "Carpenters' District of Ontario". The designation is further amended to reflect the change of certain local union numbers as a result of amalgamations since 1980. Specifically, Local 27 now encompasses all of the former carpenter local unions of the Carpenters' District Council of Toronto and Vicinity (Locals 27, 666, 681, 1133, 1617, 1963, 1747, 3227, 3233, 1304, 2480, 2482 and 2965). Local 38 has been absorbed into Local 18. Local 562L was amalgamated with Local 785. Local 1316 has been amalgamated with Local 1946. Local 2466 was amalgamated with Local 93.

Accordingly, the amended designation reads as follows:


Pursuant to clause a of subsection 1 of section 153 of the *Labour Relations Act, 1995*, I hereby designate the United Brotherhood of Carpenters and Joiners of America and the Carpenters' District Council of Ontario, United Brotherhood of Carpenters and Joiners of America as the employee bargaining agency to represent in bargaining all Journeymen and Apprentice Carpenters other than Millwrights, represented by the following affiliated bargaining agents:

1. United Brotherhood of Carpenters and Joiners of America; or
2. Carpenters' District Council of Ontario, United Brotherhood of Carpenters and Joiners of America; or
 - (1) The Ontario Provincial Council of Ontario, United Brotherhood of Carpenters and Joiners of America, or the
 - (2) The Carpenters' District Council of Toronto and Vicinity, or the
 - (3) Lake Ontario District Council, or the
 - (4) Western Ontario District Council, or the
 - (5) Ontario Acoustical and Drywall District Council; or
3. the following Local Unions: 18, 27, 93, 249, 397, 446, 494, 572, 675, 785, 1071, 1256, 1450, 1669, 1946, 1988, 2041, 2050, 2222, 2451, 2486 of the United Brotherhood of Carpenters and Joiners of America or their predecessors; or
4. any other Local of the United Brotherhood of Carpenters and Joiners of America which in the future may be chartered to represent Journeymen and Apprentice Carpenters other than Millwrights,

(Which Council and Unions are hereinafter collectively referred to as the "Unions"), in the industrial, commercial and institutional sector of the construction industry in the Province of Ontario, and without limiting the generality of the foregoing, bargaining as aforesaid in relation to bargaining rights of the Unions or any of them and the performance of work described in or covered by:

- (a) certificates of the Ontario Labour Relations Board to the Union or any of them;
- (b) voluntary recognition agreements between the Unions or any of them and any employers;
- (c) collective agreements to which the Union or any of them or their predecessors have been or are party to or bound by, covering the industrial, commercial and institutional sector of the construction industry in the Province of Ontario.
