- (b) bridges, overpasses and underpasses (including walkways, curbs and concrete guardrails formed and poured in place as an integral part of the structure), including associated retaining walls and abutments;
- (c) elevated guideways, LRT systems, intermediate capacity transportation systems and work of a similar type;
- (d) cut and cover subway construction, subway stations below grade (buildings constructed above grade over subway construction or stations falling within the industrial, commercial and institutional sector), retaining walls in open cut sections or subway;
- (e) cut and cover tunnel construction;
- (f) docks, wharfs and canals for the use of marine traffic, shore based or stemming from the shore;
- (g) field precast manufacturing operations where such operations are an integral part of the work as defined in (a) through (e);

(h) pile driving work and diving work associated with any of the above types of construction.
